

Minnesota Boychoir *fun!*RAISER OFFICIAL RULES

1. NO PURCHASE, DONATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS *fun!*RAISER. Void where prohibited by law. Subject to all federal, state and local laws.
2. WHO IS ELIGIBLE: Open to legal residents of the USA, 18 years of age or older as of their date of entry. Void where prohibited by law. Ineligible to win: Minnesota Boychoir staff, board members and their household members; Minnesota Boychoir choir members, their parents and siblings. Potential winners are subject to verification, the results of which must be satisfactory in the Minnesota Boychoir's absolute discretion.
3. HOW TO ENTER: The *fun!*RAISER begins September 26 and ends December 15, 2009 (the "Promotion Period").
 - 1) Enter by Invitation. Enter by completing a ticket, or by directing that a ticket be completed on your behalf, when invited by a Minnesota Boychoir member during the Promotion Period. You must provide correct information in all required fields (name, address, city, state, zip code, phone number). Entries that are incomplete or non-compliant with these Official Rules will be void.
 - 2) Enter by Mail. During the Promotion Period, fill out a 3" x 5" card, with name, address, city, state, zip code and phone number, and mail it to: The Minnesota Boychoir, Landmark Center, 75 West Fifth Street, Suite 411, Saint Paul, MN 55102. No photocopied or mechanically reproduced tickets will be accepted. Limit one entry per day per person and one entry per postmarked outer mailing envelope. Requests must be received by December 15, 2009 at 12:00 Noon CST to be included in the chance to win prizes. Proof of sending will not be deemed to be proof of receipt; responsibility for receipt of entry rests solely with the entrant. The Minnesota Boychoir is not responsible for incorrect, inaccurate or incomplete entry of information or for entries which are lost, late, delayed, misdirected, damaged, incompletely received, otherwise defective or lost due to any reason, all of which will be voided. All entries become the property of the Minnesota Boychoir and will not be acknowledged or returned.
4. WHAT YOU COULD WIN: A) One (1) Grand Prize winner will receive \$1,000 dollars cash; B) One (1) Second Grand Prize winner will receive \$750 dollars cash; and, C) One (1) Third Grand Prize winner will receive \$500 dollars cash. Applicable to all prize winners: Limit one prize per person per street address; Liability for any applicable taxes, including all federal, state, and local taxes and/or other fees that may apply to prizes are the sole responsibility of the winners and any required tax reporting forms will be furnished to the Internal Revenue Service; No substitution or transfer of prize is permitted; the Minnesota Boychoir reserves the right to substitute a prize of equal or greater value, if the advertised prize becomes unavailable; Acceptance of prize constitutes permission to the Minnesota Boychoir without any further compensation, consideration, notice, review or consent, to unconditionally and irrevocably use your name, city and state of residence to the extent permitted by law.
5. HOW YOU WIN? Three prize winners will be selected in a random drawing conducted by the Minnesota Boychoir on or about January 3, 2010 from among all entries received. All prizes will be awarded. Odds of winning will depend upon the total number of entries received. Three attempts to contact the potential Prize winners by mail and/or telephone or e-mail at the postal address/phone number/e-mail address provided with entry will be made. Actual means of notification will be determined by the Minnesota Boychoir at its sole discretion. If the potential Grand Prize winners are unable to be reached within five (5) days of the third contact attempt, or refuse to accept their prize, the potential winner(s) will be disqualified and an alternate winner will be selected by random drawing. In the event the potential winner is a minor, the prize may be awarded in the name of his/her parent or legal guardian who shall be responsible for fulfilling all requirements imposed on the winner in these Official Rules. The potential Grand Prize winners will be required to certify eligibility; failure of potential winners to do so will void all right, claim and interest in or to the Grand Prizes. 6. **CONDUCT.** By entering this *fun!*RAISER, each entrant agrees to be bound by these Official Rules and by the decisions of the Minnesota Boychoir and its agents, which are final and binding in all respects. The Minnesota Boychoir reserves the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the *fun!*RAISER or of acting in violation of the Official Rules.
7. **LIMITATION OF LIABILITY.** No liability is assumed for illegible or incomplete entry information or for technical malfunctions, or failed, incorrect, inaccurate, incomplete, or delayed communications irrespective of cause. If, in the Minnesota Boychoir' opinion, there is any suspected or actual evidence of tampering with any portion of the *fun!*RAISER, or if technical difficulties or unauthorized intervention compromise the integrity of the *fun!*RAISER, the Minnesota Boychoir reserves the right, at its sole discretion, to (a) suspend or cancel the *fun!*RAISER in part or its entirety; (b) void any suspected entries, and/or (c) conduct a random drawing to award the prizes using all the entries received prior to suspension or cancellation. The Minnesota Boychoir is not responsible for any typographical or other error in the printing of these Official Rules or any materials associated with the administration of the *fun!*RAISER or the announcement of the prizes.
8. **RELEASE.** Each winner, by acceptance of the prizes, acknowledges that there may be risks inherent in the prizes and that a winner may sustain losses from acceptance and enjoyment of the prizes. Each winner voluntarily assumes (for him/herself, his/her heirs, executors, representatives, administrators, assigns and next of kin) all such risks, foreseeable or otherwise, whatever the cause, that a winner may sustain, including without limitation losses caused by property damage, injury, illness or death, a negligent act or a negligent failure to act in connection with the delivery, receipt, enjoyment, ownership or use of the prize ("Losses"). All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and the Minnesota Boychoir in connection with the *fun!*RAISER, shall be governed by, and construed in accordance with the laws of the State of Minnesota, without giving effect to any choice of law or conflict of law, rules or provisions (whether of the State of Minnesota or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than the State of Minnesota.
